HE REAL RISK

Nearly 1,800 global third-party relationship, risk management and compliance professionals in corporate organizations took part in our new survey.

65%

of respondents know or suspect that third parties they conduct business with may have been involved in a range of illegal, environmentally damaging activities.

61%

of respondents (6 in 10) believe that prosecution would be unlikely if they breached third-party related regulations. 93%

of respondents say that spending increased after an enforcement action is taken related to third-party risk.





WILDLIFE TRAFFICKING LINKS WITH HUMAN HEALTH

- Recognition that wildlife trafficking is not only a conservation issue (impacts security and health)
- COVID-19 has hit aviation hard [\$419 billion in revenue losses; 7.5 million cancelled flights (Jan to July 2020)]
- As recovery starts, increased awareness that pandemic prevention will be an important new corporate risk driver
- Initial research indicates COVID-19 closely resembles virus identified in bats and pangolins
- Wildlife trafficking research indicates significant smuggling of wild (bushmeat) animal products by passengers










WILDLIFE TRAFFICKING: POST-RECOVERY RESPONSE

- Poaching and stockpiling will rise during lockdown
- Zoonotic disease outbreaks will increase in frequency and intensity
- Smuggling of wild (bush) meat represents a significant exposure route
- Focused passenger education and enhanced enforcement on high risk routes
- Need for a Pandemic Prevention Partnership between private and public sector (health, agriculture and wildlife)
- Enhanced technological cooperation (e-freight; RFID baggage tags; autodetection)
- Recognition that bushmeat smuggling is a "Green Crime"
